

**Our experienced team will carry out your auction in accordance with best practice and industry standards.**

#### **Advertising**

We will work with you to develop a programme for advertising your auction and will then make the necessary arrangements to then put the advertising in place (at your cost).

As part of this, we will advertise your auction on our website and through other means as set out in this On-Farm Auction Confirmation Form (for example, newspaper and flyers) and as otherwise agreed in writing between us.

You will be responsible for the actual costs of advertising incurred by us, whether the auction proceeds or not. For the avoidance of any doubt, advertising costs are in addition to our Commission.

We will also give notice of your auction to all our Livestock Specialists across New Zealand and to our customers who we think might be potential purchasers of the Stock. Our large customer database is one of the advantages of using us for your auction.

#### **Commission**

Our Commission will be payable by you if the Stock are sold at the auction or sold after the auction in accordance with Clause 18 of the NZSSAA Conditions of Sale.

We may deduct our Commission (and any other money owed to us, for example the advertising costs referred to above) from money received by us on your behalf.

#### **Retention**

You irrevocably authorise us to retain and hold 5% of the Purchase Price of the Stock (as received by us on your behalf) for 28 days following the auction date.

You also irrevocably authorise us to release this retention (or part of) to the Purchaser of the Stock, if the Purchaser has a right to any refund of the Purchase Price and/or compensation from you under the NZSSAA Conditions of Sale or any other agreed term of the purchase.

We will release the balance of the retention to you after the 28 day period, unless there is a dispute in relation to whether or not the Purchaser has a right to the retention (or part of), in which case we are entitled to continue to hold the retention until such dispute is resolved.

#### **Your obligations**

We will work with you to prepare for, and carry out, the auction.

If you or any member of your team want to assist during the auction, we can allocate suitable roles.

To enable us to carry out the auction, you must before, during and/or after the auction (as the case may be):

give us clear instructions and provide us with all information relevant to the Stock;

provide us with all applicable policies that apply to your property (for example, health and safety, environmental and biosecurity policies);

provide us with unobstructed and safe access to the property and notify us of any potential hazards on the property that may pose a risk to us or our equipment;

ensure the property is in a clean and tidy condition and free of debris;

provide us with access to wash-down our equipment; and

comply with our reasonable instructions (including in relation to health and safety and security of our equipment).

After the auction, we can return to your property to assist with the Stock if required (including organise delivery of the Stock, at the relevant parties cost).

#### **Circumstances beyond our control**

If, due to circumstances beyond our reasonable control (including inclement weather), we cannot carry out the auction as planned, we will work with you to make alternative arrangements for the auction (including rescheduling the auction if required).
