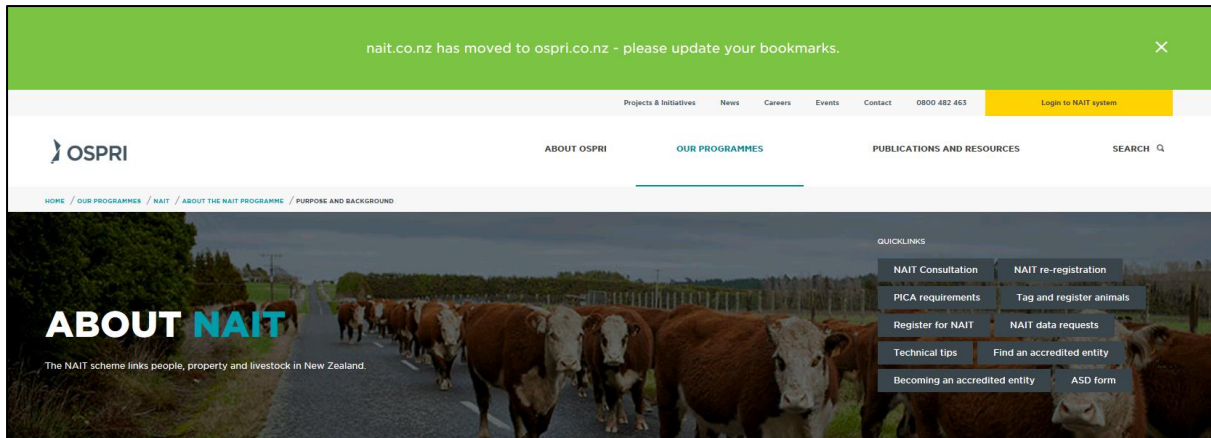

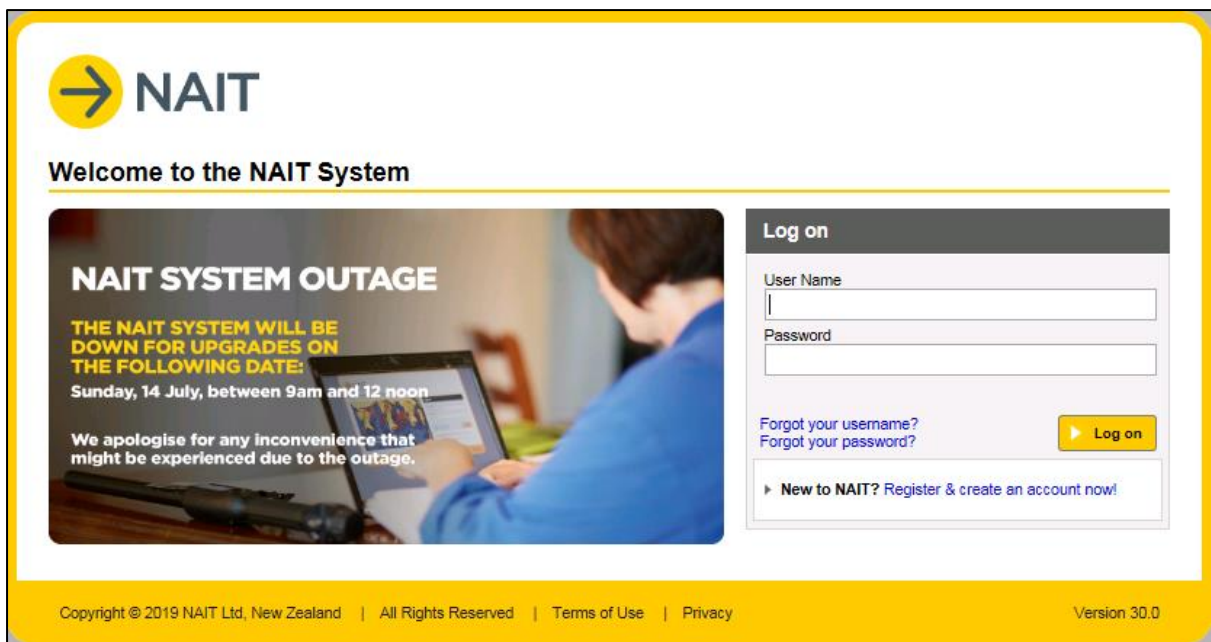

Nominating NZ Farmers Livestock as an Information Provider

1. Log into your NAIT Account by in your web browser entering www.ospri.co.nz and you will have the below site display.



2. Click on the tab “Login to NAIT System” and enter your Username and Password.



3. On the Home screen select the NAIT Number that you wish to assign to NZ Farmers Livestock as an Information Provider from “Your NAIT Numbers”.

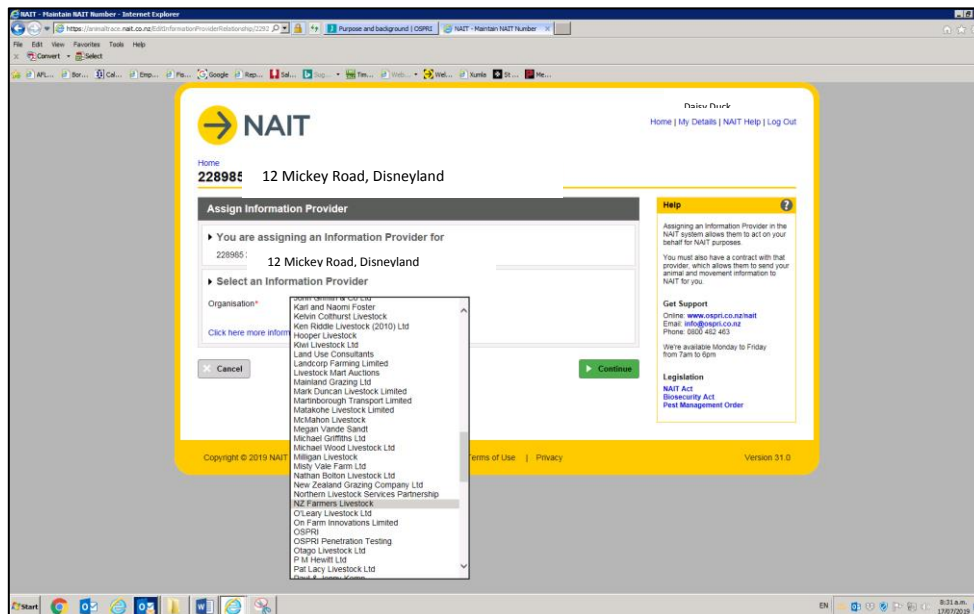

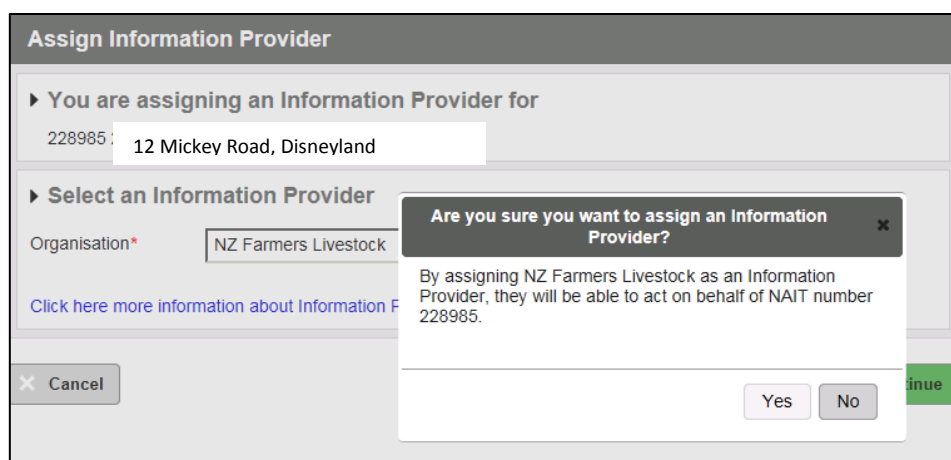

Why should I opt to give NZ Farmers Livestock Ltd as my NAIT Information Provider?

- NZ Farmers Livestock Ltd as a NAIT Information Provider may complete my NAIT Registration on my behalf.

- I confirm that I am the owner or lessee or I am otherwise authorised by the owner or lessee to register as the PGCA for all the NAIT animals I have identified at the NAIT location I have specified to NZ Farmers Livestock Ltd.
- I understand and agree to comply with all of my statutory NAIT obligations and regulatory requirements.
- I authorise NZ Farmers Livestock Ltd to provide all required information, including personal information, to the NAIT organisation to enable NZ Farmers Livestock Ltd to perform its duties as an information provider.
- I acknowledge that I remain responsible for compliance with the Act, in respect of all the PGCA duties and responsibilities, and I agree that NZ Farmers Livestock Ltd shall not be liable to me or any third party for any breach of my statutory NAIT obligations and regulatory requirements.
- I am required by NZ Farmers Livestock to register them as an Information Provider either by ringing NAIT on 0800 434 443 or registering them online in my NAIT Account.
